1. Technical committee on « land tenure and development» and objectives of this guide

What does the committee do?

- The 'Land Tenure and Development' Technical Committee is a working group created by the French Cooperation in 1996 **to discuss rural and urban land issues** in developing countries across Africa, Asia and Latin America.
- It operates under the auspices of **the Ministry of Foreign Affairs and International Development (MAEDI) and the French Development Agency (AFD).**



What is its mission?

- **To support the formulation and implementation of land policies** that effectively address key land issues in developing countries (promoting equitable access to land and functional land management mechanisms).
- **To increase recognition of the multiplicity of land rights** and the need for **multi-actor dialogue** around land issues.
- **To stimulate debate and inform thinking** and actions by land policy actors and their partners in different countries and continents.



Formalising frameworks for land-related analysis and action

- Facilitating multi-actor reflection in two main areas:
 - **Formalising rights and responsibilities:** analysing the tools, benefits, risks and shortcomings of policies to formalise rights, and their implications for security of tenure.
 - **Transparency and contract negotiations:** providing a framework for ex-ante analysis, and training materials to assess the quality of previous agreements for agro-industrial projects that affect local land rights

Objectives of the work on « transparency and contract negotiation »

Provide an analytical framework to assess the legality, legitimacy and equity of land relations in agricultural investment projects

- Relations between different stakeholders
- Negotiation process, legality of transactions, specific clauses in the contracts, institutional framework
- Equity and sustainability criteria

Draw operational recommendations for the French cooperation on due diligence that should be included in land-based investment projects

- Support negotiation process
- Structure and clauses of contracts
- Mechanisms for monitoring and implementing commitments

July 2013 : review of existing voluntary guidelines and case study selection



July-August 2013 : 10 case study analysis



September 2013 : presentation of the conclusions drawn from the case studies



Pays	Description
Mali	Sugarcane production project. South African company controlled by a British firm and the Malian government.
Libéria	Oil Palm production project. The main shareholder is a Singaporean company. Contract signed by the central government.
Sénégal	Agrofuel production (sweet potatoes and sunflower). Project delocalized after a violent conflict that had led to several victims. Implication of local collectivities.
Cameroun	Oil palm production. US company and central government (initially targeted area of 73 000 ha between several conservation areas; multidimensional impact analysis realized with an international NGO
Ghana	Jatropha production. Norwegian company. On going project. Customary authorities involved.
Sierra Leone	Sugarcane production, Swiss investor, BAD involved, implementation phase of the contract. Land transaction with customary rights owners, contract with the government too. RSPO certification.
Laos	Eucalyptus and acacia production, Swedish company, on going contract, very small scale project with extension plans. Innovative approach with interesting dispositions such as those concerning small scale contract farmers.
Ethiopie	Horticultural production, Indian society, start up phase in different parts of the country.
Côte d'Ivoire	Hevea production. Interesting feasibility study that have shown lake of awareness about land based relations in agreements. Project abandoned by the company.
Madagascar	Jatropha production, Italian company. Division in small parcels to avoid including land with crops or settlements. Lack or badly carried consultations of local population. Uncertain legal status of pastures that undermine the legalization of customary rights.

Status of land and recognition of local land rights

- Recognition of local land rights

- Institutional capacity to critically assess investment projects
- Consultation with affected communities

- Nature of the transaction
- Parties to the contract and strategic actors
- Local consultation and popular consent
- Preliminary studies
- Transparency in the negotiation process

Contract management

- Contract management, including mechanisms for monitoring and implementing commitments
- Exit and renegotiation clauses
- Conflict resolution mechanisms

Analysis of the project and associated contracts : economic evaluation

General context

- Current dynamics and relevance of the project
- Consistency between the project's stated objectives and national and international development objectives
- Business model

Financial and economic analysis

- Financial evaluation
- Jobs and opportunities for small producers
- Income generation and tax revenues
- Development of economic and social infrastructures or services
- Distribution of added value between different actors
- Monitoring and implementing commitments

Analysis of the project and associated contracts : social component

Recognition of local land rights

- Social impact assessment
- Recognition of affected people with a socio-land survey
- Use of the minimum of necessary resources and analysis of alternative solutions
- Conditions for resettling and compensating local people for expropriated land

Working conditions

- Comply with national labor law and international norms
- Monitoring and implementing commitments

Analysis of the project and associated contracts : Environmental considerations

Equitable access to natural resources

- Environmental impact assessment
- Conditions of natural resource use and priority conditions to assess

Environmental safeguards

- Project reversibility
- Protection of water resources, analyze of competition risks
- Clauses applicable in the event of environmental damages
- Monitoring and implementing commitments

Conclusions

Main findings

- Compliance with national legislation does not automatically protect local people's rights
- All projects that will displace people should be subject to an economic evaluation
- The transparency and inclusiveness of the processes to negotiate contractual arrangements is an indicator of more equitable agreements
- The need for a process to rebalance asymmetric relations between private investors, the State, local governments and local people
- Contractual clauses need to be specific with clear conditions for their implementation, monitoring control

Conclusions

Main findings

- Capacity building for civil society actors is still a key issue
- Priority should be given to the creation of a network of experts on land matters
- Thinking about large-scale investment raises broader questions about the local governance and agricultural models the should be promoted for the future
- Technical and financial partners play a key role in helping governments and private enterprises respect the principles of the voluntary guidelines

Way forward

Several activities

- Integrate these criteria in the social and environmental due diligence of AFD and Proparco supported projects (example of a project in Ghana)
- Presentation of this operational guide to the French private sector
- Debate with other donors (GDPWL)
